Requirements for the update

- All Coalitions are required to complete their FULL updated strategic plan by June 15, 2017.
 - Negotiate timeline with your System Manager to develop a plan for reviewing sections of your SP.
- Use the Community Coalition Guide (Updated August 2015).
- Appendix 4: Sample Timeline of Comprehensive Plan Update 2017.
 - 24 steps to completing your strategic plan outlined by months.

Getting Started and Capacity

August 2016 – February 2017

Get the coalition organized by completing the Getting Started and Capacity Building section in the Coalition Guide.

- Begin documenting key decisions about how the coalition is organized and continue throughout the year.
- Build the coalition's cultural competency, focus on health disparities, CLAS Standards, and sustainability with the coalition.



Getting Started and Capacity

August 2016 – February 2017

- Review Membership
 - ensure 8 sectors, develop recruitment plan, & coalition orientation.
- Organizational Development
 - Discuss coalition structure. Is there a need for workgroups? (YES)
- Revisit Coalition Mission/Vision
 - Adjust and update the coalition Mission/Vision.



Assessment

September 2016 – April 2017

Begin and complete:

- Needs Assessment
- Resources Assessment
- Gaps Analysis
- Prioritize Local Conditions (Risk/Protective Factors)

Assessment

August 2016 – April 2017

- Develop a process and a team to conduct all assessment activities.
- Set up a meeting with the coalition to determine how the group will prioritize identified risk and protective factors.
- Gather local data, conduct focus groups, and key informant interviews while waiting for your HYS data and Data Books.
- Data books will be available in March 2017.
- Conduct your Community Survey and assess in Jan/Feb,
- Conduct Coalition Assessment Tool (CAT) survey and share with the coalition.



Planning

March 2017 – May 2017

- Coalition develops goals and objectives.
- *Coalition* develops strategies and activities. and timelines for implementation.
- Write coalition's Plan for Action of program implementation section of the SP.
- Complete the Coalition's Logic Model.
- Develop a budget for your action plan.



Planning

April 2017 – May 2017

- Confirm partnerships.
- Write Executive Summary of the coalition's SP.
- Have the coalition review sections of the SP draft.
- Revise the SP based on the coalition feedback.



Implementation

July 2016 – June 2017

- As you have been, continue to implement your current action plan.
- Write your strategic plan.
- Maintain active community coalition.
- Participate in monthly DBHR Meetings.

Reporting and Evaluation

- Determine how the coalition will measure progress.
 - Process Measures
 - Evaluation Measures
- Decide on pre/post tests that fit both the local conditions and the program.
- Complete PBPS reporting on time (15th of each month).
- Participate in statewide evaluation.

Review and Approval of the Strategic Plan

- Coalition should review revised draft of their SP.
- Send draft of the Plan to your Prevention System Manager for review.
- Be sure to *answer all questions* in the writing guidance section of your guide.
- Make final revisions to the Plan based on feedback by May 15, 2016.
- Get *Coalition* Approval to DBHR for review by June 15, 2016.
- Once approved, publicize Strategic Plan to coalition, partners and community.

The 2016 Community Survey Format, Questions, Length

2016 Survey – Formats

- Survey instrument
 - One CORE survey
 - Coalition-added questions ("Coalition-specific survey")
- Survey administration options
 - Hard copy surveys
 - Online survey links: English, Spanish, Data-Entry for hard-copy surveys
- Languages
 - Cambodian/Khmer, Chinese, English, Somali, Spanish, Russian,
 Vietnamese

Survey Length

- Survey length year-to-year
 - Long surveys every <u>EVEN</u> year
 - Shorter surveys every <u>ODD</u> year
- EVEN YEARS EXAMPLE 2014
 - CORE: 31 Questions
- ODD YEAR EXAMPLE 2015
 - CORE: 21 questions
 - 10 questions were rotated off from the 2014 survey

2016 Survey Length

- 2016 Community Survey
 - CORE 32 Questions
 - 29 questions taken or adapted from 2014 & 2015 surveys
 - 3 new questions
- Hard copy layout for printing
 - Survey introduction and contact information 2 pages (1 page double-sided)
 - Survey questions 6 total pages (3 pages double-sided)

 - Cathy Kelley, Sunnyside United-Unidos coalition
 - Danny Highley, DBHR Prevention System Manager
- Provided recommendations for 2016 Community Survey after...
 - Reviewing & adapting questions from other federal, state, and local substance abuse survey instruments
 - Taking into account new health issues of concern
