In 2000, Washington State adopted a bold vision to eliminate traffic deaths and serious injuries on our roads by 2030. Over the past 15 years, we have seen tremendous progress toward Target Zero. Traffic deaths are at record lows in spite of increases in population, number of vehicles on our roadways, and miles traveled. While Washington has been combating impaired driving for decades and has made significant progress, impaired driving continues to be the main factor in fatal collisions. Impaired drivers were a factor in 43 percent (583 of 1,331) of all traffic deaths and 1,391 of serious injuries between 2011 and 2013. Drivers in fatal crashes were as likely to be impaired by drugs as by alcohol. Many were impaired by both. Significantly reducing the incidence of impaired driving is recognized as the top priority in the Target Zero Plan.

To support the Target Zero Plan, WTSC established the Washington Impaired Driving Advisory Council (WIDAC) in 2009. In alignment with Target Zero, the WIDAC provides a comprehensive strategy for preventing and reducing impaired driving behaviors. Washington's system-wide approach to addressing impaired driving has led to support for prevention initiatives, comprehensive ignition interlock laws, better law enforcement and prosecutor training, more DUI Courts, and innovative, targeted, full time DUI enforcement teams.

To support WIDAC strategies, it is my pleasure to announce the availability of state impaired driving grant funding for the 2015-2017 Biennium. This announcement is intended to solicit proposals from organizations throughout the state creating and implementing leading-edge strategies to curb impaired driver behaviors that result in preventable and unnecessary loss of life. It is my hope that the proposals we receive will strike a balance between strategies we know to be effective and those that will help us break new ground in identifying innovative, yet measurable strategies that respond to emerging challenges.

I invite you to put your talent and resources to work in helping us reach this worthy goal. I hope you will consider developing a proposal that strengthens our coalition and contributes to the important work of eliminating traffic deaths and serious injuries by 2030.
