

System enhancements:

We are excited to announce, the following system enhancements were made based on feedback we have received from you!

Enhancements include:

- Provide a security setting in the user profile that will allow partner and participant names to be displayed in session details for multiple staff of the same Performing Entity. (See below)
- Provide the ability to copy session details to subsequent sessions to reduce data entry burden.
- Prevent duplicate participant entries in the sessions
- In session details, provide a "session name" field to simplify how we find prior sessions.
- In the sessions form, only display partners/staff associated with the performing entity selected in the activity log.
- Other minor changes to increase usability were also made.

NOTE: For those of you that share data entry for a performing entity and would like to request that multiple users are able to view the names of participants and partners (not just ID numbers), please send a request through the help desk. You must include the user names and emails of each person you would like to have access to the Performing Entity. Only the primary contact can request other users to have access to the Performing Entity



LEGISLATIVE UPDATES



2017 Legislative Session –Marijuana Bills

Bill/Companion Bill	Title/Description
SSB 5284 – Marijuana Advertising	Addressing the oversight and regulation of marijuana by banning outdoor advertisements including billboards and sign spinners. Senate Rules Committee
SHB 1712 – Marijuana Delivery	Establishing an endorsement to the marijuana retailer's license to authorize marijuana delivery services subject to local ordinance and LCB rules. House Appropriations Committee
SHB 1060 – Student Medical Marijuana	Concerning the administration of marijuana to students for medical purposes. Requires school district to adopt policies at parent’s request for non-smokable/inhalable medical marijuana use at school, on bus, or at a school event. If any part of the act is found to conflict with federal requirements, then those conflicting parts must be declared inoperative. House Appropriations Committee
HB 1487 – Marijuana Merchandise	Authorizing marijuana retailers to sell branded marijuana merchandise. House Rules Committee
SHB 1212 – Possession, Transfer, Home Grow	Legalizes non-commercial transfer of marijuana between 21+ adults with limits, allows home grow of up to six plants for 21+ adults, and possession of up to 24oz of marijuana from legal home grow. House Finance Committee
HB 1250 – Lockable Drug Box	Authorizing retail marijuana outlets to give a free lockable drug box to adults 21+ and to qualifying patients age eighteen years and over subject to restrictions. House Rules Committee
HB 2021 – Medical Plants and Seed	An act relating to authorizing the sale of marijuana plants and seeds to qualifying patients and designated providers from marijuana producers. House Finance Committee
HB 1099 – Unofficial Moratoria	Addressing local governments' unofficial moratoria on state-licensed marijuana retail outlets by requiring liquor and marijuana tax revenue forfeiture if there is not an ordinance or resolution explicitly prohibiting the operation of marijuana retail businesses. House Appropriations Committee



2017 Legislative Session—Bills related to Alcohol, Tobacco, Vaping & Mental Health.

Bill/Companion Bill	Title/Description
Alcohol: HB 1874 – Breath Alcohol Concentration (BAC)	Addressing the blood and breath alcohol concentration of persons operating or in physical control of a vehicle, vessel, or aircraft by reducing the per se BAC limit from 0.08 to 0.05. House Transportation Committee
Alcohol: SSB 5161 – Alcohol in Theaters	The theater license authorizing the sale of beer, strong beer, and wine is no longer limited to theaters with up to four screens. Senate Floor
Alcohol: SHB 1039 – Wine Growlers	Allowing sales of growlers of wine. House Rules Committee
Tobacco/Vapor: SHB 1054 – 21+	Concerning the age of individuals at which sale or distribution of tobacco and vapor products may be made by increasing the restricted age of sale from 18 to 21 years old. House Rules Committee
Prescriptions: SHB 1047 - Medication Disposal System	Protecting the public's health by creating a system for safe and secure collection and disposal of unwanted medications. House Appropriations Committee
Prescriptions: SHB 1339 – Opioid Drug Prescriptions	Providing for restrictions on prescriptions for opioid drugs by limiting initial prescriptions for opioid drugs for outpatient use to a seven-day supply, or a three-day supply if prescribed by a dentist. House Rules Comm.
Mental Health: SHB 1377 – Student Mental Health	Improving students' mental health by enhancing nonacademic professional services. House Appropriations Committee
Mental Health: SHB 1379 – Higher Ed. Behavioral Health	Implementing a comprehensive approach to suicide prevention and behavioral health in higher education. House Appropriations Committee
