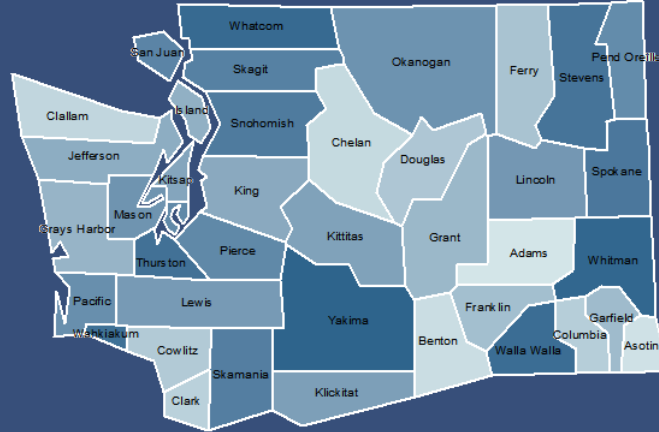

What is a HIDTA?

- High Intensity Drug Trafficking Area
- Mission: Reduce drug trafficking and misuse through collaboration
- Overseen by the Office of National Drug Control Policy under the Executive Office of the President
- Funding is authorized by Congress annually



NW HIDTA

- 15 counties, 90% population
- Drug task forces
 - Federal, state, tribal, and local agencies
- Prevention & treatment
 - Grant program
 - Overdose Response Strategy



2023 RFP Process

- Predictors of Application Success:
 - Clear and measurable goals and objectives
 - Demonstration of understanding of evidence
 - Prioritization of evaluation/evaluation implementation
 - Cross-sector collaboration

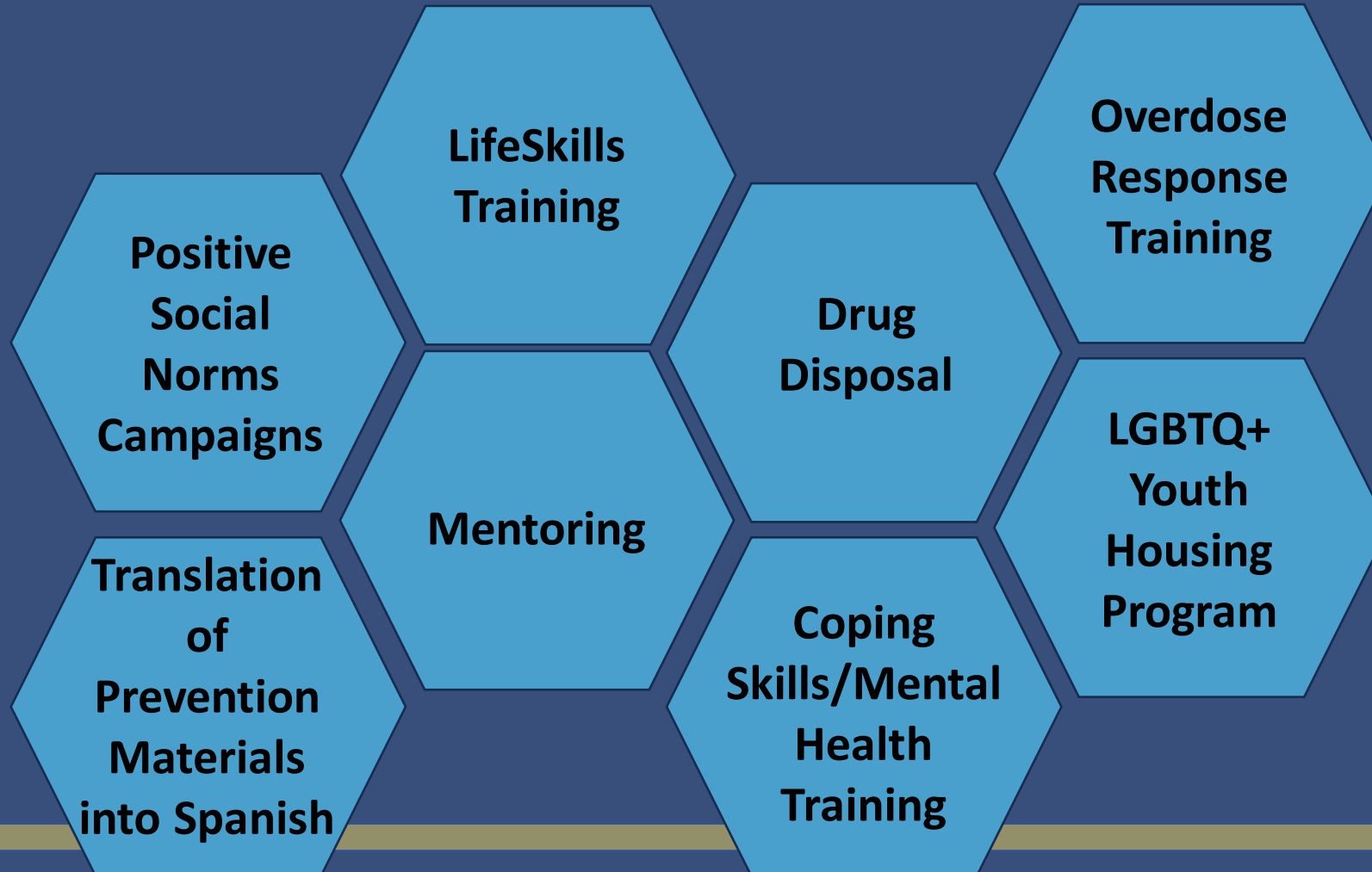

YCCTPP mission

- Prevent initiation and reduce cannabis and commercial tobacco use by youth ages 12-20
- Support adults and peers who influence these youth
- Leverage resources for promoting and supporting commercial tobacco dependence treatment for all ages, and
- Reduce cannabis and commercial tobacco-related inequities within Washington State

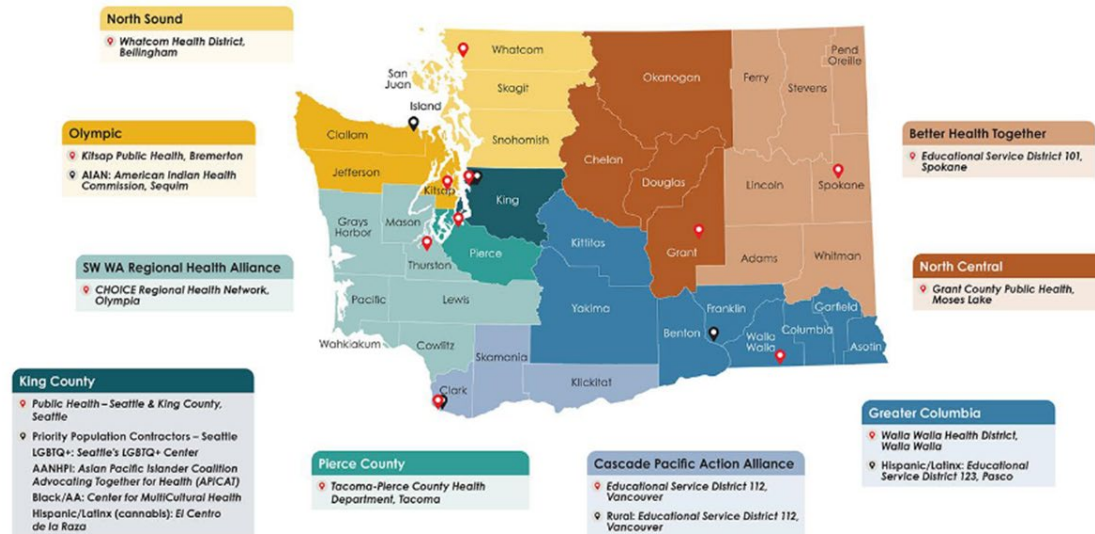

Funding Priorities of Community Grantees

- Capacity building efforts for **new and emerging organizations**, including
 - *Creating an infrastructure to support applying for other state and national prevention opportunities*
- Capacity building efforts for **current prevention coalitions and other prevention professionals** actively implementing prevention programs and strategies to leverage funding to allow for continued capacity building and expansion
- Developing culturally appropriate, effective, and sustainable prevention practices appropriate for the population being served
- Addressing the disproportionate impact of cannabis and commercial tobacco on people of color

Funding Priorities of Community Grantees continued

- Collaborating with cross-sector partners, including youth and other community partners
- Working with community members with intersecting identities
- Addressing social determinants of health, that can change community-level conditions to create more opportunities for healthy living including:
 - *Physical Environment, Education, Employment, and Socio-Cultural Environment*
- Strategically working to disrupt root causes of health inequities including Institutional and Structural
- Implementing PSE to address racism and other forms of oppression and its effects on well-being and health outcomes

Policy, Systems, and Environmental Change (PSE)

- **Policy Change**
 - Approaches that address law, regulation, procedure, administrative action, or voluntary practices of government or other institutions
- **Systems Change**
 - Approaches that address impact of all elements including social norms of an organization, institution, or system
- **Environmental Change**
 - Approaches may include physical changes to the social, physical, or economic environment

PSE Strategies of Community Grantees

- Community-led initiatives that address inequities that might lead to youth cannabis and commercial tobacco use
- Development of community skills in advocacy for policy change, including those addressing social determinants of health
- Strategies that help limit youth access to cannabis or commercial tobacco products
- Strategies that address social and community norms around youth cannabis and commercial tobacco use
- Opportunities and spaces for people to positively socialize, challenge social norms that promote misuse, share cultural traditions, and build community
- Strategies that address consequences associated with youth use & focus on addressing equitable & holistic approaches

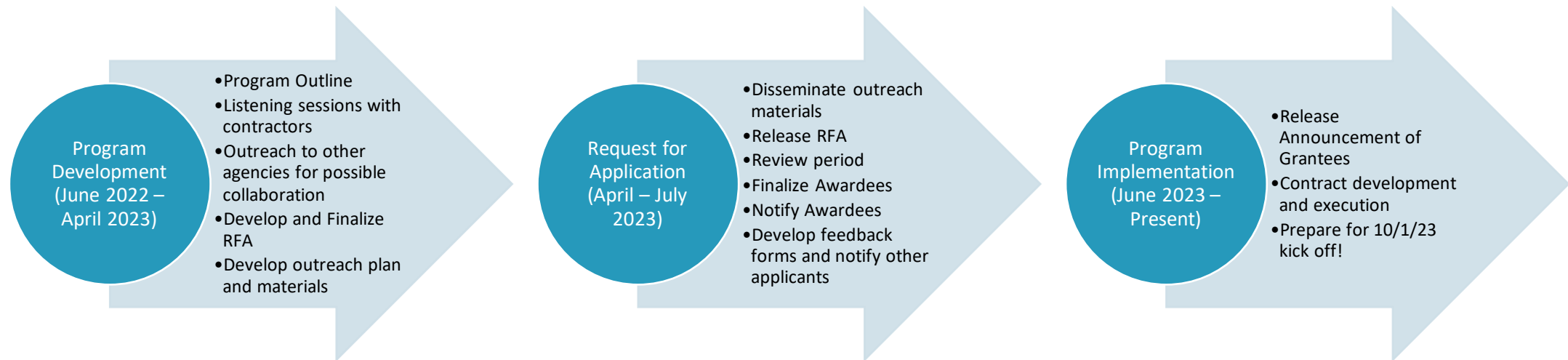
