1. **Introductions and Announcements**

Sarah Mariani

- Sarah opened the meeting at 1:06 p.m.

- Self-introductions followed.

2. **2024 Legislative Primer – SPE Policy Statements** *Isaac Wulff, Harrison Fontaine*

- SPE has its own page on the Athena Forum, which is where the new [5-Year Plan](#) is posted.
- Harrison and Isaac went through the new policy statements (page 9).
 - Covered how each policy statement aligns with previous legislation examples.
- Some bills to watch for in the upcoming Legislative Session (as related to policy statements) may include topics like:
 - THC regulation
 - Flavored tobacco
 - Cannabis advertising – reducing size requirements
 - Regulating price of products

- Excise taxes related to THC potency or to wine
- Equity in cannabis retail
- Suggestion: include some of this on a 1-pager with pictures of products to help inform education policy and legislative staff even prior to the Legislative Session.

3. **Statewide Survey on Traffic Safety Behaviors** *Staci Hoff, WTSC*

- Staci started off with the background of the 104-question driving behavior survey and shared some key findings, which are available on her PowerPoint.
- 10,964 surveys were completed over all Washington counties; minimum goals exceeded in all. 20% survey completion rate of all sent.
- 18 infographics are already available on their [website](#).
- Outcomes should be available in Spanish next year.
- Survey Result Dashboards and Excel files are also available so you can see the data behind each question.
- Q: Have you noted any root shared risk and protective factors? A: We're trying to get more into shared risk and protective factors. One example – Does the family have **rules** about distracted or impaired driving, etc. Get schools involved, too.
- Q: How local can we go? Are there ways to partner across agencies to support communities in using this data? A: Putting the dashboards and unweighted data out there can be helpful in reaching the local level sooner.
- Q: How often are the dashboards updated? A: 3x/year.

4. **SPE 5 Year Plan - *Released*** *Alicia Hughes, HCA*

- HCA presented the plan at a 2-hour session at the Provider Meeting prior to the Prevention Summit.

- Opioid Prevention *Alicia Hughes*
 - Responding to leg requestions around opioid abatement and decision packages
 - Looking for responses from folks in the field who use the dashboard
 - 2nd phase of Fentanyl campaign released last month and covered at Px Summit
 - Send agenda ideas to Erika Jenkins

- Problem Gambling Prevention *Roxanne Waldron*
 - Starts in January and will meet about every two months for 18 months.
 - Focus: 1 – Work with HCA Px staff to determine what components should be in the statewide prevention plan.
 - 2 - Develop an online toolkit to be a statewide resource.
 - Brought materials to the Px Summit, but all were for adults. Will focus on developing youth materials.
 - Seeking a DOH member to join the group.
- Washington Breathes *Heidi Glesmann*
 - Their coalition organizer attended and presented at the Px Summit.
 - Were able to share materials there.
 - Shared at the Healthy Youth Survey Workgroup.
 - The final training of a series with the Center of Black Health and Equity is on December 7 from 10-11:30 am. [Register here.](#)
- WHY Coalition *Martha Williams*
 - New Healthy Youth Research unit shared at a WHY meeting. It will help the WHY Coalition inform policy and explore how to use the data.
 - Doing retrospective work looking toward the coming year. Looking to increase work engaging youth.
 - WHY Cannabinoid Workgroup is reconvening this month. Expecting a lot of legislative work this year.

 - WHY Communications Team led a poster activity at the Px Summit to update the prevention history timeline. Taking suggestions on notable events. Please send event suggestions to Kendra.Wilson@hca.wa.gov.
- Young Adult Workgroup *Rachel Oliver*
 - Finishing informational interviews to help ground team in the mission and find ways to increase engagement and information sharing.

- Additional updates and announcements:
 - HCA's Children's Behavioral Health Workgroup just finished a report with 2024 recommendations, part 1. Next will be the Statement of Support.
 - WSIPP published several reports in September; another, focused on high schools and HYS data, is coming at the end of December.
 - OSPI is still using the helpful 2021 data for presentations. Have a big health equity focus. Now have 4 local AWARE sites through Federal SAMHSA Aware grants. Funding 2 new positions: Tribal Mental Health, SUD Prevention work at schools.
 - YCCTPP has a co-manager: Marie Gray is now DOH's Community Partnership Manager. She comes from WSU and worked in suicide prevention and the intersection with cannabis use.
 - Eliza Powell presented at the Px Summit on program evaluation, which was well received. They hope to expand their technical assistance and training capabilities.
 - Brittany Weiner, WSHA: They held a webinar where they highlighted both October's Substance Use Misuse Prevention Month and education as a prevention tool.
 - Julie Peterson will forward some items of interest to the group the first week of December. Pay attention to the November budget forecast. The 2024 session calendar is out. The House schedule is out. There's a lot of interest in Fentanyl, but not in the connected way they'd hoped.
 - DOH has two grants stating a new 5-year cycle: cardiovascular disease prevention and diabetes prevention. Both focus on equity this year. Connecting chronic disease prevention and behavior.
