


Deliver resources and supports to schools for developing and implementing systems of support to eliminate educational equity gaps so all student outcomes increase.

Theory of Action: We believe, **IF** we support schools in developing and implementing systems of support and promote evidence-based programming and sound implementation practices, **THEN** educational gaps will be reduced/eliminated, **RESULTING IN** an overall state graduation rate of 90% by 2027.


Lifelines Trilogy Curriculum



SAMHSA AWARE Grant

Advancing Wellness and Resilience in Education

Train school personnel and other adults who interact with school-aged youth to detect and respond to mental health issues.



Increase awareness of mental health issues among school aged youth and their families through the development, implementation, and sustainability of a comprehensive school-based system of mental health services and supports.

Connect school-aged youth who have behavioral health issues and their families to needed services.



Comprehensive Guidance & Counseling (CGC)

Implementation of HB 5030

- Align the work of school counselors to best practice.
- CGC is one component of a broad student support system; ideally, the broader system includes supports from other professionals, like school social workers, school psychologists, school nurses, and community-based professionals.
- 80% of school counselors' time is to be spent in direct AND indirect service to students.
 20% is designated for program planning and school support activities.



Educational Service District Behavioral Health COVID Response (ESSER)

The OSPI/AESD Behavioral Health COVID Response project will deploy:

- 51 Student Assistance Professionals
 - Providing substance abuse and mental health prevention and intervention services
- 9 Regional Behavioral Health COVID Response Coordinators
- 9 Regional Student Assistance Advocates

Needs assessment to help inform student supports during the pandemic.

Data used for *Academic & Student Well-Being Recovery Plans* that were submitted in June 2021.

LifeSkills Grants



Two grants are currently available to schools that serve middle school students

1) LifeSkills Substance Abuse Prevention Grant;

Provides funds for schools to be trained in the curriculum, purchase it and teach the Botvin LifeSkills Middle School Program

2) Readiness to Implement Grant;

Provides funds for schools to review their Healthy Youth Survey data; identify needs; review Botvin LifeSkills Middle School Program and decide if the curriculum is a good fit for them

WHY Accomplishments 2021



February

- Presentation by Gillian Schauer on Delta-8 THC. Coalition suggests creating a fact sheet for Px professional; an ad hoc team was assembled.
- The 2021 Legislative session brought several bills with focus on Marijuana and Alcohol. Coalition members were kept informed on bill movement.
- Prevention Voices and WASAVP, active members of the Coalition, provided information and training concerning advocacy.
- Communications Team reviewed the underage drinking prevention campaign and suggested updates to forward to the media team on updating the campaign; the team brainstormed ideas for STN Face Book posts.
- Communications Team: a sub-team started review of the Start Talking Now website's Community page.

March

- Prevention Voices and WASAVP continued their work during the legislative session.
- Jesse Havens presented on the MVAPE administration and results.
- Communications Team: Start Talking Now Community page edits were reviewed; the site was updated.
- Communications Team: new version of A Parent's Guide to Raising Drug Free Kids was reviewed and suggestions were made for the media team.

April

- Members had the opportunity to suggest future WHY presentations.
- The Delta-8 THC Ad Hoc team presented the Delta-8 brief being worked on
- Members attended the April YMPEP meeting on Delta-8.
- Communications Team: reviewed the new version of the Parents Guide.
- Communications Team: reviewed the Delta-8 THC Fact Sheet and provided input.
- Communications Team: provided input for STN Facebook posts.

May

- Leg session wrapped up with many successes.
- The Delta-8 Fact Sheet was submitted to HCA management for approval; the Coalition agreed that the release of the Fact Sheet will need to be discussed including who the fact sheet is aimed at educating.
- WASAVP and Prevention Voices continue their work on educating people on the legislative process and the need for advocacy

June

- Julia Dilley presented on the Alcohol Home Delivery Tool; Coalition members agreed to beta test the tool.
- The Delta-8 THC Fact Sheet was disseminated to prevention professionals.
- Communications Team: welcomed Nikki Meline (DOH).
- Communications Team: was provided an update and copy of the Delta-8 THC Fact Sheet.

WHY Accomplishments 2021



- August
- Julia Dilley returned to present the results of the Alcohol Home Delivery Tool beta test; about half of the sample tests were out of compliance. Next steps (Alcohol Action Network) were shared.
- Coalition members revisited the Marijuana vs. Cannabis Terminology history related to HB1210 on terminology.
- Members were encouraged to attend the LCB listening sessions on alcohol allowances and to share information at those sessions.
- Prevention Voices and WASAPV continued an active role at WHY offering training sessions and creating a network of agencies to ensure participation in legislation and rulemaking.
- The Delta-8 THC Ad Hoc Team: discussed what several other states have been grappling with concerning Delta-8.
- September
- Jason provided an update on the COVID Student Survey.
- Communications Team: STN Website Home page and About Us section was reviewed by Alex.
- Delta-8 Ad Hoc Team: the September meeting included a review of LCB's draft Agency request and provided feedback on language therein.

- October
- Chris and Brian (LCB) provided an update on the Agency request to the Delta-8 Ad Hoc Team.
- Communications Team: WA Tech has offered to provide training to the team on how to update the STN website; the training will occur at the January 2022 meeting.
- November/December
- Policy analysis worksheet will be discussed.
- Delta-8 Ad Hoc Team: members will discuss the CDC Action Alert on Delta-8.
- Delta-8 Ad Hoc Team: Jacob will be taking the lead on the meetings.
- Communications Team: team members will rotate taking the lead on the meetings.
- Communications Team: GMMB is working on DOH campaigns for youth, foster parents and other audiences such as rural and statewide; working to be more inclusive.
