


## Prevention Overview and Background

- Supports the **promotion of wellness and resiliency** to reduce future risk.
- Address risk and protective factors to prevent suicide and disordered eating.
- Funding to plan and implement programming for individuals, families, and communities.
- Delay the onset of substance use, reduce the risk for future problems related to problem alcohol, tobacco, cannabis, opioids and other drugs.
- Improve overall wellbeing by increasing emotional wellness and resiliency skills.





# Institute of Medicine Spectrum of Mental, Emotional, and Behavioral Interventions







## FOA Purpose

- Increase community capacity to implement direct service programs and strategies to communities experiencing the highest need and risk in our state.
- Expand the reach of prevention actives beyond existing Community Prevention and Wellness Initiative (CPWI) communities. Partnership with local community coalitions is encouraged:
  - Community Prevention and Wellness Initiative (CPWI)
  - Drug Free Community (DFC)
  - Department of Health (DOH)





## **Eligible Entities**

Tribal governments, Urban Indian Organizations, other Tribal organizations, government agencies, educational organizations, behavioral health organizations, youth and family serving organizations, primary care organizations, public or private organizations, non-profits, faith-based organizations, or community coalitions.

- Minimum Qualifications:
  - Licensed to do business in Washington state
  - Experience managing or providing at least one (1) community-based program for a minimum of two (2) years





## **Prioritized Applications**

- Applications that provide services that support HCA's values of health equity and reduce health disparities
- Prioritized Applications may receive bonus points by should they include services in communities of one of the following categories:
  - Current CPWI Coalitions
  - Community with the Highest Risk and Need

## Successful Applicant Contract Expectations

#### Successful applicants will be required to, but not limited to, complete the following:

- Finalize an approved Action Plan and Budget.
- Hire any needed staff for coordination and/or implementation.
- Implement selected Direct Service Programs and Strategies
- Attend and complete required trainings on fiscal requirements, contract compliance, Minerva, and program implementation throughout the contract period.
- Participate in check-in phone calls with Contract Manager or designee, and other assigned Contractor meetings.
- Complete monthly reporting, ensuring all program service delivery data is recorded.
- Submit all billing invoices within 45 days of the end of the billing month to HCA.



## Implementation Expectations

Programs and strategies are to be implemented with full fidelity unless otherwise approved by the program developer and HCA/DBHR

- Full fidelity requires implementation to be as originally intended by the program developer. Changes (i.e. adaptation) that you may consider for approval include, but are not limited to:
  - Program implementation
  - Intended participants
  - Session cadence and length
  - Language
  - Setting

- May 5, 2025 Successful Applicants Announced
- ▶ May 15, 2025 Action Plan and Budget training (Part 2)
- ▶ July 1, 2025 Estimated Contract Start Date!

    - Ensure responses to all narrative questions addresses each of the fund sources applying for

  - Application may be submitted only as a Microsoft Word document or a saved PDF
  - ► Ensure all necessary documents are included.





#### **Evaluation Overview**

○ Total of 95\* points available, plus 10 Bonus Points

#### 3 Sections:

- Section 1: General Application Information (not scored)
- Section 2: Narrative (80 Points)
- Section 3: Budget Narrative (15 points)

#### Bonus Points (optional)

- Prioritized Communities (5 points)
- Coalition Letter of Support (5 points)

\*Potential total points. Points will be calculated separately for each funding source.
Within the Application packet, you will see indicated sections where responses will be evaluated independently for each funding source.






#### **Evaluation Overview**

- A team of evaluators reviews each application
- Evaluators assign a score (0-5) for each question, using a Qualitative
   Assessment tool
- Total Score (per fund source) is compiled

QUALITATIVE ASSESSMENT
5 = Excellent
4 = Very Good
3 = Acceptable
2 = Marginal
1 = Unacceptable
0= Nonresponsive
