SPE grant - \$600,000 for one year. PRI communities can receive mini grants to bring in primary health care providers to your coalitions. Funding of \$25,000 - \$30,000 will be available for primary health care providers to do prevention projects. This funding is anticipated to be available before the end of the year. Training Plan: The training plan is for assisting coalitions with completing their strategic plan. Scott Waller reviewed the training plan document which can be found on www.TheAthenaForum.org. Things to note: Be sure to register on The Athena Forum. We have a provided a number of samples and templates for you to use. They are all posted on Athena in PRI Task Category Guide folder. A very important step that many of you are currently working on is the Key Leader Orientation event. This task is important because coalitions tend to be more successful when they start off with a unified understanding of how everyone will go forward (common language, theory, roles, etc). If these coalitions can also reach out to key leaders in their community, they are more successful. The tasks will be done over time, with guidance on when they should happen. The timeline overview is a suggestion on when to logically roll items out. You need to work with your prevention system manager on your timeline. In the training plan, in addition to the phone TA and template presentations, some of the trainings are identified as trainings. These trainings include the Key Leader/Community Board Orientation (CBO) training; Community Assessment Training/Clinic (plus contributing factors); and Community Planning Training/Clinic (develop Proposed Plan).
