b. Review 2016 Funding Opportunities

- i. Application information (Do's and Don'ts)
 - --The application MUST be filed through Grants.gov. You can't use Grants.gov unless you have a SAM registration. How to register for both Grants.gov and SAM will be clearly stated in the FOA. These two registrations should be the FIRST THING YOU do after the FOA is posted.
 - --Don't leave anything out of the application—this includes attachments AND any information requested in the application. If for any reason you can't supply any information, make sure you include why you can't and, if applicable, how you plan remedy this.
 - --Get a group of people to help you write the application—divide the sections up.
 - --Once posted, the FOA can we downloaded at ONDCP.DFC.GOV or at SAMHSA.GOV.GRANTS
- ii. DFC FOA updates—There have been some changes, but I suggest if you are going to apply you go to last year's FOA (RFA as it was called last year) and work on that if you want to get a head start.
- iii. DFC Mentoring FOA updates—The DFC Mentoring FOA will be posted around the end of December and due in early April
- iv. STOP Act FOA updates—There is a good chance there will be funds available for STOP Act grants this year. I'll keep you posted!
- v. Application Hotline—The DFC and DFC Mentoring Hotline will begin the day the FOA is posted. The application will be out of service at midnight the day the FOA is due.
- c. DFC Me—If you are not registered with DFC Me, please register immediately. This is a requirement for DFC coalitions. You should email <u>DFC Evaluators@icfi.com</u> or call 1-877-854-0731. To help expedite, please provide your coalition name and grant number.
