1. ESD 121 - Puget Sound, Renton: Role Clarity Success stories - what the Student Assistance Specialists do for school based prevention. Case study stories - kids making a difference in their lives
2. ESD 114 - Olympic, Bremerton: PBPS- problems Rural Strategies
3. ESD 114 - Olympic, Bremerton: I think it is helpful when people share success stories or successful prevention efforts, including all the necessary handouts, materials created that can be used to potentially replicate the event/effort.
4. ESD 123: Network- see what others are doing
5. ESD 171 - North Central, Wenatchee: Review what individual coalitions are doing related to marijuana prevention. Talk about what the youth prevention clubs are doing this year, activities, focus. Talk about regionalization of Traffic Safety/Target Zero offices.
