What is the ESDs Role?	
They've been pretty involved as we have started up. Their role will be less as time goes on.	

- Nancy F: With the DFC year-one done, we will be doing coalition training and can share how we do the training. The ESD in this community continues to be involved in the coalition.
- Diane: In the beginning we were more involved with Othello, as they have a long-standing coalition. We are staying directly involved in Pasco since it's a new coalition, and will work with Teresa to help establish the coalition.
- Maureen: I go to all four coalition meetings every month.

What is the county's role?

- Joe Fuller: Our coalition has been around for a while sustainability is on the front burner. We have ½ of one- percent funding but need to continue to find more funding. We are looking at training opportunities for members, planning a retreat for coalition members, getting lots of community feedback about trends. It's been great to have Maureen's expertise.
- Joe Niegel: Maureen has been very valuable. Over the last 12 months the challenge has been being a govt representative, and not being accepted as a community member. Working on building relationships, and tempering good intentions with research and doing what is known to be effective, laying foundations for a meaningful coalition experience.
- King: Four of our two coalitions we have had a slow start. It's a learning process as a county person. We are trying to make sure the coalitions have the resources they need. We are enhancing what is being done at the Vashon middle school with prevention education, looking at their strategic plan and helping them to update it. Trying to figure out titles for each of our roles.
- Pierce: It is a challenge to separate our county role from our community coordinator role. Balancing act of helping and getting involved, but not taking over.
- Randy, Central Seattle Coordinator: We have strategies, and the coalition wonders if we need help from the
 county on updating them. This is not an immediate concern for us we can update our strategies at any
 time.
- Renee Hunter: I play a dual role a little of the county role and a little of the community coordinator. Our coalition was a SPF-SIG community. With PRI it's more environmental and policy issues, so it's a bit of a challenge to get the coalition to change direction. Our meetings are held at the schools so this helps bridge the relationships. We have a very active youth coalition I'm not sure if I can ask the PI to help with getting them involved in PRI. Who do I ask? This should be the coalition's decision. OSPI: youth groups are an important component of Project Success, but need to discuss whether there will be staffing/time issues with direct services.
- Megan Azzano: We are actively collaborating on data sources with our PI to figure out what to report to the
 coalition. We have a DFC grant that I coordinate, along with being the community coordinator for PRI, and
 county coordinator.
- Teresa Bell: There is sometimes some conflict among roles. The coordinator role is really about building relationships with the community at large and within the coalition. The county position is more focused on PBPS reporting and other DBHR requirements. Tommy Otis is our new PEI. He has been a big part of a recent, successful school event, where he got to meet local providers and family members. His school is

about 1,000 students with a large percentage who are English language learners.

What is the coalition coordinator role?

- When we talk about the coordinator, we are talking about the community coordinator. In some counties there are already community coordinators there who are managing DFC grants. When the county employee says they are the community coordinator, this can be confusing.
- DBHR suggests choosing another title for county staff. DBHR wants to have <u>direct contact</u> with the actual <u>community</u> coordinators.
- Some of the larger counties like King have had several discussion about this. King thinks a better title may be PRI project coordinator (who is the liaison between DBHR and the coalition). Jackie: we are not funding the DFC coordinator with PRI funds, so concerned about direct contact with DBHR. The county staff are trained to keep in close contact with the community coordinators.
- DBHR: It is mostly during our monthly meetings that we want to have community coordinators present. Eventually, we will not need as many DBHR meetings. We need the community coordinator to follow the PRI guidelines, regardless of who their funding source is.
- King County/Jackie: I try to make sure the community coordinators are following the guidelines, but will need to have a discussion with them about attending the DBHR meetings.
- Pierce/Hae Man: Coalition members are confused about roles and some still ask what is PRI? What might help for Orting is if the coalition members understood more about PRI, and how their involvement helps with this project. It would be helpful if DBHR came out and did a presentation on PRI.
- DBHR/Linda B: It may help all of us if we went back to basics and discussed what the fundamental approach
 is for PRI. A comprehensive community-based strategy includes a coalition, but this is only one part of it. A
 P/EI specialist is important, school-based programs, strategies that involve families, other domains. We will
 be collecting pre and post data, as well as data about the coalition process. We want to find out if we can
 make significant changes through implementing a comprehensive, community-wide strategy, across many
 domains.
- Hae Man: Getting all the players at the same table, with coalition members not being paid, is an issue.
- Randy: We have multiple coalitions, community agencies, churches, hospitals in our community. Local conditions and what you have there already can differ and need to be part of an ongoing discussion.
- Diane S: We've had coalitions for a long time. They have had all the sectors represented, but there is an ebb and flow with economic situations. We may need to identify those who have had lots of experience with coalitions, what changes they had to deal with over time, and what we can learn from them.
- Randy: My community has 3,000 students so one P/EI may not be enough to see change, compared to communities that have one P/EI for 1,000 students.
- Aaron Stark shared sector reports. Cohorts need detailed instruction on setting up access for online coalition surveys.

Environmental Prevention Applications – Scott Waller/DBHR

The application packet went out Nov 21. Due date is Dec 14. We will score applications based on readiness to participate. In early January we will announce which communities will be involved. Call Scott if you have questions. Question: Didn't DBHR say there would be a pool of applicants that would then be randomly selected? Scott: We

	need to fund communities that can begin working immediately with Dr. Holder, as there is a short time frame.
SPE Grant – Sarah Mariani/DBHR	You should have all received an email before the Prevention Summit asking for interest in an SPE project. We have received responses for Part A (involving a primary care rep on your coalition) and B (\$23,000 available for a collaborative project with primary care). The RFP letter is out – let Sarah know right away if you did not receive it – this was sent out from our contracts office. Key dates: Dec 5 to submit questions to the DBHR contracts office – Sandra Elliott. Dec 7: Answers to questions will be distributed. Dec 21: proposals due by 8pm. DBHR will announce proposals selected within one week after due date.
Budget Update	 A \$40 million budget cut to state-funded treatment is proposed. We don't know yet how prevention will be affected. So far, the federal government is not proposing a significant decrease for prevention. For the Block Grant, the House has proposed a reduction. For the Enforcing Underage Drinking Laws grant, budget was cut from \$20 million to \$7 million – we are looking at having only a quarter of the funding we have now. Community Mobilization and the Family Policy Council are still zeroed out in the Governor's Budget. For DBHR, prevention is currently 25% of the block grant, but based on the treatment cuts, this may go down to 20%. DBHR has a waiver from the feds for matching the block grant with state funds. OSPI: For PEI we have federal block grant funding. There has been substantial cuts to basic education funding, and to student support funding, like Readiness to Learn. On Dec 8th there is a work session on the privatization of liquor sales about implementing the bill. Healthy Youth Survey Funding: We do have funding as of right now and have a contractor in place. This would fund the state sample and the individual schools. Youth Suicide Prevention Program – Is this zeroed out in the Governor's Budget? Dixie will find out. Is there any chance that the legislators will look at taking out the proviso for shifting funding in county budgets? DBHR has not heard about this being removed. DBHR: As we move forward with PRI, we recommend that DFC representatives be on board for their insight to the process. We have asked the Coalition of Coalitions (COC) to be part of PRI discussions. Randy B. is now the co-chair of the COC. He and Steve Smothers will talk. Melanie/Yakima: Re Proviso: I'm not sure how this affects funding distribution. DBHR: A proviso came out two sessions ago that the funding formula we have now with counties can't be changed until the proviso ends. A few counties approached legislators about implementing this proviso, which then affecte
Cohort 2 Updates on Community Selection Process	 In Yakima Cohort 2 received data books. People have been looking at the data to decide which community to select. Is there any feedback about decisions so far? Questions? 101: Our highest risk school district is Spokane SD with a population of 4,800. The Spokane Regional Health District is working with us to help identify at least three distinct communities.
	 Asotin: Our human services board has agreed to be our core workgroup. We have not yet identified a school district but know which community. Whitman: Most of our services are based in Pullman. Lincoln: We will be meeting with the ESD next Fri to go over our data. 105: We've been meeting with our prevention manager and the ESD. We only have one community that is above 50 percent and want to know where the data came from since the sample was so small for the Thorp

	SD. It is census data? We want to look at a community that is below 50% and will talk with our school
	districts. Will follow up with Linda Becker.
	 Yakima: We've met with our advisory groups about the data and are in the process of choosing between four communities. We still have 8 communities above 90%.
