PORT TOWNSEND Prevention Redesign Initiative

Port Townsend is one of 19 communities statewide selected to receive support to focus on keeping youth, young adults and others free of alcohol and other drug misuse, while creating healthier communities. The program is called Prevention Redesign Initiative (PRI). It is a collaboration between Olympic Educational Service District 114, Port Townsend School District, Jefferson County Public Health and the Jefferson County Community Network. It is funded by the state Department of Social and Health Services' Division of Behavioral Health and Recovery (DBHR). Jefferson County Community Network will facilitate the program through a PRI work group. The Jefferson County Community

Network (JCCN) is a prevention advocacy organization that brings parents, schools, agencies, and community groups together to work on preventing youth substance abuse and child abuse/neglect. The JCCN is part of the Family Policy Council, a DSHS agency that focuses on social issues at the local level by working with County Networks state wide. The JCCN is also Jefferson County's policy board for the Washington State Community Mobilization program. The Community Network is governed by a policy board consisting of citizen volunteers and representatives from local agencies.



What is the true cost of substance abuse?

In 2010 the Jefferson Co. Substance Abuse Advisory Board did a comprehensive review and report of public funding spent on the direct and indirect costs associated with substance abuse in Jefferson Co. for 2007. The report was modeled on a study completed by Columbia University's Center of Alcohol and Substance Abuse (CASA). The cost was estimated at over \$17 million.
