Intervening Variable: Alcohol, Marijuana and Prescription Drug Availability

Local Condition: Youth report that alcohol and marijuana are easy to get, with the main source being "near peers" (e.g., young adults – including siblings and relatives) at parties and also at home with parent permission and parent-sanctioned parties. Prescription drugs are not being secured by adults and youth are easily accessing them.
